

# PRIVACY POLICY

When registering on the site, as well as filling out the order forms for goods and services on the site <https://advant.club/>, ticking the box that you are familiar with this Privacy Policy (hereinafter - the Privacy Policy), you consent to Advant Global Services Ltd. (PO Box 590, Suite 9, Henville Building, Charlestown, Nevis, Federation of Saint Kitts and Nevis), hereinafter - the "Company", as well as Suppliers (business entities offering their goods or services in the search and information system of the site, for the purpose of their acquisition by Users/Independent Partners) for the processing of your personal data in order to ensure the implementation of contractual relations for providing access to the use of the online search engine of the site [https://advant.club](https://advant.club/) (hereinafter referred to as the System), as well as for the purpose of accepting and serving your orders for goods or services on the site, properly providing you with goods or services using the site.

You also agree that the Owner of personal data has the right to provide access and transfer your personal data to third parties without any additional messages, if this does not change the purpose of their processing, and only if you yourself made a certain order with such third parties through the site. The name of such third parties is contained in the information about the offered product/service, which you can familiarize yourself with before ordering.

Your personal data collected on this site is confidential information for the Company. We value your right not to disclose your personal data. This Privacy Policy is the rules used by all our employees/contractors/executors and governs the collection and use of personal data that may be requested /received when using the System or when ordering goods/services on the Site. We are acting in accordance with this Privacy Policy.

## **VOLUME OF PERSONAL DATA**

---

When registering on the site, placing an order to purchase any product/service on the site and filling out any other registration form (order), you provide your personal data for processing. In particular, it can be: name, address, phone number, e-mail address, passport data, date of birth, bank card details, IP-address, data about your Traveling Companions (if specified by you), your photo (if uploaded by you), delivery address, as well as, with the permission of other individuals, if ordering goods/services for them - their personal data accordingly. Everything that is described in relation to your personal data applies equally to the personal data of other individuals specified by you.

## **Information that the Company can collect about you automatically:**

---

During a visit to the site, certain information is automatically collected that does not allow identifying the user. This information may include the following:

1) View statistics,

The Company collects information about the sections of the site that are mainly viewed by users, the frequency of connections to the site, software and hardware used to visit the site, the location of users. This information allows the Company to understand the way users interact with the Site.

2) Magazines,

The equipment of the hosting provider of the Company may record the requests made by the users of the site, information about the software and hardware used to visit the site, the assignment of the IP address, and the time associated with access. The Company uses this information to improve the security of the Site.

### 3) Cookies,

A cookie is a text string that a site sends to a browser cookie on a user's computer so that the site can remember the user's preferences. The company uses these cookies to analyze user behavior and improve the experience of website users. The User can disable cookies by using the browser settings.

We receive such data only from persons who provide them knowingly and at their own request.

In order to register, place an order for goods or services on the Site or otherwise interact with the Company or Suppliers, you should carefully read your rights and obligations in the field of personal data processing, carefully read this Privacy Policy, and express your full consent with these conditions.

### **As a data subject, you have the right to:**

---

- 1) know about the sources of collection, the location of your personal data, the purpose of their processing, the location or place of residence of the owner (controller) of personal data or give an appropriate order to receive this information to authorized persons, except in cases established by law;
- 2) receive information about the conditions for providing access to personal data, including information about third parties to whom his personal data is transferred;
- 3) access to your personal data;
- 4) receive an answer about whether your personal data is being processed, as well as receive the content of such personal data, no later than thirty calendar days from the date of receipt of the request, except as otherwise provided by law;
- 6) submit a reasoned demand to change or destroy your personal data by any owner (controller) of personal data, if these data are processed illegally or are unreliable;
- 7) protect your personal data from illegal processing and accidental loss, destruction, damage due to deliberate concealment, failure to provide or untimely provision of them, as well as to protect against the provision of information that is unreliable or defaming the honor, dignity and business reputation of an individual;
- 8) file complaints about the processing of your personal data with the Company, an authorized person/body or a court;
- 9) apply remedies in case of violation of legislation on the protection of personal data;
- 10) make clauses on the limitation of the right to process your personal data when giving consent;
- 11) withdraw consent to the processing of personal data;
- 12) know the mechanism of automatic processing of personal data;
- 13) to be protected from an automated solution that has legal consequences for him.

**You must** indicate only accurate, reliable personal data and update them as necessary, since the main sources of information about you are the data that you have indicated about yourself.

## Purpose of collecting personal data

---

Personal data - information or a set of information about an individual who is identified or can be specifically identified.

We may process your personal data for the following purposes. In this case, one or several goals can be applied simultaneously:

**Help in using the Site.** We may use your personal data to provide answers to your questions, to provide technical assistance in using the site and to answer your other questions regarding the site.

**Order Processing.** Either Suppliers or we can use your personal data to receive your order, to process your order, or for other purposes that may exist to achieve the ultimate goal - to satisfy your interests as a consumer when ordering goods/services, as well as to prevent and investigate cases of fraud and other abuse.

**Communication with you.** Either Suppliers or we may use your personal data to contact you, for example, inform you about changes in goods/services or transmit important messages and other similar messages regarding an order that you have placed; contact you for purposes related to serving you as a consumer/user/independent partner.

## Transfer of personal data to third parties

---

We do not sell, transfer, or disclose personal data that we receive on our site to third parties without your prior consent. We disclose personal data only in cases determined by applicable law, as well as:

We will disclose information in the event of crime prevention or damage to us or to third parties;

We will disclose information to third parties who provide us with technical support and services (including Internet acquiring, delivery services, etc.) through which you receive your order,

as well as those third parties who are Suppliers and whose goods/ services are offered on the site or in the System for purchase.

## Deletion of your personal data

---

You have the right to change/delete some of your personal data in the System yourself or delete your data at any time by contacting the email address: [support@advant.club](mailto:support@advant.club).

The deletion of the User's/Independent Partner's data by the Company at the request of the User/Independent Partner itself leads to the blocking of the account and the impossibility of its recovery. Some features of changing personal data may be provided for in the Accession Agreement.
