

Remuneration Plan

We are pleased that you have chosen Advant Travel as a partner to create your own stable financial future. Our goal is to provide you with a high quality Advant Travel service that you will use and proudly recommend to others.

As soon as you understand how strong and popular our product is, you will immediately want to tell the world about it. Your income will be directly related to your efforts to promote the Advant Travel service and demonstrate your prospects, as well as efforts to build your business structure.

Definitions and abbreviations

The Company is Advant Travel Ltd., registered office - P.O. Box 590, Suites 5 Horsfords Business Centre, Long Point Road, Charlestown, Nevis, Federation of Saint Kitts and Nevis.

Sponsor is an individual who has previously accepted the terms and conditions of cooperation with Advant Travel and invited a new distributor via a personal recommendation link.

Distributor is an individual who has accepted the Accession Agreement, has access rights to the search and information system of the Company's website and the right to receive remuneration under the terms of this REMUNERATION PLAN.

Website is the Company's official website located at <https://advant.club>.

System is a search and information system of the Website <https://advant.club>, which allows the User to find and buy online offers of products and services of the Company's Partners.

Package is a package of services of the Company, which determines the terms, functions and services for the distributor's account.

Time interval is a time period from 00:00:01 Sunday to 23:59:59 Saturday of one week (7 full days) that is taken as the basis for making payments and accruals.

VP (volume points) are the volume points taken into account when implementing Advant Travel packages in the business structure for calculating distributor rewards. Information about the current exchange rate for points (1 VP = 1 USD) is available in the "Finance" section of the distributor's personal account.

I. ADVANT TRAVEL SERVICE PACKAGES

The User receives the right to use the website system after registration on the website via an individual recommendation link, which can only be sent by a previously registered distributor-sponsor (owner of one of the affiliate packages). By activating the selected service package, the distributor is entitled to receive remuneration.

Registration takes effect after acceptance of the terms of the Accession Agreement and the Distribution Agreement when filling out the online form. Each package includes certain terms of cooperation with the Company and different terms of remuneration (see III. Remunerations).

II. CAREER LEVELS

Career level is the title of a distributor, which requires the fulfillment of certain conditions for building a personal business structure. A personal business structure is a set of distributor registrations that have been invited either personally by a distributor or by personal, previously invited distributors by providing an individual recommendation link. Distributors who are at different career levels are entitled to different percentages and types of remuneration depending on their career level (see III. Remunerations).

The following career levels are available for Advant Travel distributors:

CAREER LEVEL	NECESSARY CONDITIONS FOR REACHING THE LEVEL
START	To achieve this level, you must personally implement any three service packages, inviting three users to cooperate.
MANAGER	To achieve this level, you need to create a personal structure of 3 separate branches, and each of them at any level must have at least one distributor who has reached the START level.
SUPERVISOR	To achieve this, you need to create a structure of 3 separate branches and each of them at any level must have at least one distributor who has reached the START level.
LEADER	To achieve this, you need to create a structure of 3 separate branches and each of them at any level must have at least one distributor who has reached the SUPERVISOR level.
REGIONAL LEADER	To achieve this, you need to create a structure of 3 separate branches and each of them at any level must have at least one distributor who has reached the LEADER level.
COUNTRY LEADER	To achieve this, you need to create a structure of 5 separate branches and each of them at any level must have at least one distributor who has reached the LEADER level.

INTERNATIONAL LEADER

To achieve this level, you need to create a structure of 3 separate branches, and each of them at any level must have at least one distributor who has reached the **REGIONAL LEADER** level, or create a structure of 5 separate branches and each of them at any level must have at least one distributor who has reached the **COUNTRY LEADER**.

COMPANY LEADER

To achieve this level, you need to create a structure of 3 separate branches, and each of them at any level must have at least one distributor who has reached the **INTERNATIONAL LEADER** level, or create a structure of 5 separate branches and each of them at any level must have at least one distributor who has reached the **COUNTRY LEADER**.

COMPANY'S SHAREHOLDER

To achieve this, you need to create a structure of 5 separate branches and each of them at any level must have at least one distributor who has reached the **INTERNATIONAL LEADER** level.

Reaching the next career level is determined by the state of your personal business structure at the close of the time interval (see IV. Settlement procedure). The assignment of Leader career levels and higher is provided in stages, provided that the previous levels are reached.

III. REMUNERATIONS

Advant Travel provides partners with the opportunity to receive income from distribution activities simultaneously on several types of income, each of which is formed depending on the career level, package of services, and efforts of the distributor and independently of each other.

1. Direct remuneration.

Direct remuneration can be a source of income for new distributors. Advant Travel transfers to the sponsor's internal account 5% of the amount of realized packages of the company.

2. Remuneration according to the Classic plan.

You can earn money by creating your business structure in Advant Travel. This is created specifically to reward you for the help and support given to those who have joined your team. The more you help them succeed, the higher is your income.

The Classic Plan of remuneration is an excellent income opportunity, especially in the medium and long term. To get it, it is enough to carry out 3 direct registrations, which allows to get 3% of the turnover of packages sold by distributors in the personal business structure.

Percentage values depend on the career level and are shown in the table below. If a distributor in your personal business structure has reached a certain career level, you will receive a percentage of group turnover equal to the difference between your percentage and that of the distributor, if the difference is positive.

1. Remuneration according to the Binary plan.

Available only for owners of packages **I** and **II**.

In order to receive this type of remuneration, you must activate the Binary plan. This implies a personal invitation (by providing your own recommendation link) of two users with further registration and activation of one of the available affiliate packages. The program will automatically place the first two personally invited users in different branches. In this case, the first registration will be carried out in that part of the structure, which is the most "developed in level" (in terms of the number of earlier registrations, if any), i.e., for the distributor, which is the last link of the longest sequence of registrations in one of the branches. The second and all subsequent registrations by personal recommendation link will automatically be placed in the most extreme position of the less developed branch.

After activating the Binary plan, you can intentionally place new registrations in the positions that you prefer by using a special personal recommendation link.

When packages are sold, the sales volume is created in both branches. Depending on the cost of packages purchased by new users, the corresponding volume points (VP) are awarded. When 500 points (VP) are accumulated in one branch (it does not matter in which branch or at what level) and 500 VP are accumulated in the other branch, the cycle is closed. Depending on which service package the distributor has, the recommendation is equal to 50 VP (for package **I**) or 25 VP (for package **II**). If a Binary plan has not been activated and/or the distributor is the owner of package **III**, the recommendation for the Binary plan are 0 VP.

In case the amount of VP in a branch exceeds the required 500 VP, the difference in points remains available for accounting in the next cycle. For accrual purposes, the cycles that were closed in the same calculation period in which the Binary level was activated and all subsequent cycles for the period of the affiliate package **I** or **III**) are taken into account.

The amount of your Binary plan remuneration cannot exceed 10,000 VP for a single calculation period.

The maximum payout of remuneration for a Binary plan is limited to 45% of the total amount of volume points (VP) of the entire distribution organization of the company. If, in any reporting period (see III. Settlement procedure), the total Binary plan remuneration exceeds 45% of the total company score, the actual remuneration to the entire organization will be 45% of the total VP payout, and all distributors scores will be calculated on a pro rata basis.

2. Remuneration for tours.

Owners of affiliate packages receive remuneration for the turnover of travel services (tour packages from Advant Travel partner tour operators), which is formed by the purchase of travel packages by users without an activated affiliate package (for which you are the direct sponsor) provides for the calculation of remuneration at the rate of 3% of the actual payment for the order.

Remuneration for tours is accrued after the purchased travel services are provided to the user in full on the first Monday after at least 10 days from the end of the trip.

3. Remuneration for a Forced Binary.

The basis of the activity and development of Advant Travel is legality, reliability, long-term, prestige and superprofitability. The company's special attitude to distributors who share such values is reflected in the availability of passive income generation.

For the owners of affiliate package **I**, regardless of how it was activated (by one transaction or by using an upgrade), a type of passive remuneration - Forced Binary is available. According to the conditions of this type of remuneration, the distributor is charged 1% of the amount of activated affiliate packages in the binary structure scheme. Activation of packages by users who are registered in the binary structure chart from the fourth to the fifteenth depth level inclusive in relation to the position of this distributor is taken into account. Also, further upgrades and subsequent activations of purchased affiliate packages are taken into account for remuneration accrual.

Forced Binary remuneration payments are made regardless of whether the activation of packages in the binary structure is the result of the personal actions of the distributor or his personal structure.

5. Car program.

The car program provides a special type of remuneration for the purchase of a car by those distributors of Advant Travel who have reached the career level of Regional Leader and higher. 4% of the total turnover for affiliate service packages in the personal business structure

is distributed compressively according to the Classic plan. In other words, the percentage values for accrual depend on the career level and are shown in the table below. If a distributor in your personal business structure has reached a certain career level, you will receive a percentage of his group turnover equal to the difference between your percentage and that of the distributor, if the difference is positive.

In addition, an additional credit may be granted to the Company for this type of remuneration. Its size and terms of repayment can be determined separately, individually for each case and at the discretion of the Company. In this case, the car to be purchased (make, model, body type, year of manufacture, technical condition, appearance, mileage) is agreed with the Company in each individual case and in accordance with General recommendations. This remuneration can be received once a year at one of the Company's Official Events.

6. Special remuneration for "Shareholders".

The career level of a Company Shareholder allows a distributor to participate in the Company's development. This type of remuneration involves the distribution of 10% of the net annual profit in equal parts among those distributors whose career level is a Company Shareholder. This distribution is discussed and approved annually by a meeting of the Company's management and such Company Shareholders.

IV. SETTLEMENT PROCEDURE

All payments and accruals occur at the end of the calculation period, on Monday. First, the career level is calculated, and then the remuneration is calculated, in accordance with the new current career level. This takes into account the turnover volume points (VP) spent in the calculated period from Sunday to Saturday. Accrued remuneration is transferred during the calculation period that follows the one in which the payment was ordered.

If the affiliate service package expires and there are funds not ordered for withdrawal on the balance, they can be paid separately. To do this, contact the support service using the e-mail address specified in the user profile.
